#### PASTOR'S REPORT

The Rev. Renie Stamm-Kirk



The year 2011-2012 has been an amazing year for Community Congregational, not just because we've had so many new visitors and guests, or because we've welcomed 18 new members; not just because we have baptized 10; not just because we have the most amazing music program, or that we started two new services that are set to reach out to parts of our community that have not worshipped with us before; and not because we've started our futuring projects, especially looking at our property and longevity use as well as community outreach.

All of those things happened in this last year. But I think Community Congregational is amazing because of something else. For the last five years I have seen people come and go in the life of the church. And it's true – folks are often attracted to churches because the preacher preaches great sermons, or the church has a great youth ministry, or the choir is dynamic, or the sanctuary is lovely. But those kinds of things, I've found, don't sustain them for the long haul. In this community preachers have come and gone, the choir will occasionally grow and shrink, and unfortunately youth eventually do what they're supposed to do and grow up and leave (and, sometimes, their families with them).

But I have found something else here at Benicia Community Congregational. And it's something that has been true for this faith community for the last 146 years. More and more, I'm convinced

that what attracts people to this particular church, and what keeps them here, is that they sense at some deep level that this church is authentic. Not that it has all the answers, but that it's a place where you can ask all the questions. Not that it knows exactly who we are and what we're called to do in the world, but that we're committed to the



on-going journey of discerning that. Not that we understand ourselves by negation (we are not this; we are not that...), but that we understand ourselves by affirmation.

Just look at our mission statement approved at the Congregational meeting June 2011:

Community Congregational Church's mission is to follow the example of Jesus by being a welcoming community who cares for and honors each other and the world. We welcome everyone, young and old, gay and straight, singles and families, exuberant children and inquiring adults. We celebrate our diversity in vibrant music, sacred worship and lively fellowship. As a congregation governed by our members, we are a justice-making, radically inclusive community. We seek to live fully, love wastefully and lead courageously.

This is who we ARE. This is what we believe. And most importantly, we are not defined by our fears, but by our hopes and our faith. Believing that the real mission of Community Congregational is to

bring hope to those outside of the building and beyond the congregation is vital in how we move forward. It is vital in how we are remembered. It is vital in how and who we serve.

I realize I'm a little biased, but this is who we are – authentic, real, honest and loving, and that's what attracts folks to us. So let's keep at it!



## **FUTURING**

#### Action Planning / Vision / "Leaves and Branches" Phase

This year, our Futuring process continued with action. Inspired by our new Values and Mission statements, we were now ready to tackle a vision for our future.

In keeping with our tree theme, this was called the "Leaves and Branches" phase.

It started with a "Day of Discernment" on July 23, and a follow-up evening session



on September 18, at which we brainstormed all of our inspirations and ideas for what the church could do in our future. Over 30 distinct ideas were generated. We also began to ask for individuals' commitments to the ideas.

On October 9, we held an all-church workshop called "Dreams and Priorities" facilitated by Judy Donovan of the IAF. We took the input from the previous sessions and voted on them in a manner that allowed us to see which ideas held the most interest and passion for immediate action.

The top three vote-getters happened to fall into one of the three, broad-theme categories discovered in the discernment meetings:

- Inside the Church: Explore "Alternative Worship" possibilities.
- Outside the Church: "Building Bridges" with other churches and non-profits for increased impact on social action.
- Capital Improvements: "Resurrect the Capital Improvements Plan" and create medium and long-term capital improvements and building plans for the church.



We did not, however, merely discard the remaining 27 ideas. For the Futuring Process to be a dynamic and sustainable process, we needed a "well" of new ideas from which to draw.

#### Taskforces Established

On November 9, we held a final workshop aimed at kick-starting the taskforces. The output of this highly interactive session was a poster for each of the taskforces which include an explicit purpose of the taskforce, objectives, challenges, help needed, and next actions.

#### **Futuring Culmination and Blessing of Activities**

The planning phase culminated on November 13, 2011, during a Sunday morning worship service with a presentation of posters and blessing of the activities they represent during worship service.

#### **Taskforces Actions**

As of this writing the Taskforces have formed and made substantial progress:

• Explore Alternative Worship Possibilities – Renaming themselves the "AWE" (Alternative Worship Experience") the team has developed and begun two alternative worship

experiences. The first service, held on the first Saturday of each month at 5pm began on March 3, 2012. This service is the more contemporary service and is called the S.O.U.L Service (Singing Out Universal Love). This service usually includes singing, prayer, dramatic reading and a short sermon. Each service continues to grow with twenty-six attending the last service held in June 2012.

The second service, held on the third Saturday of each month at 5pm began on March 17, 2012. This service is more contemplative in nature and includes time for meditation, conversation and readings. This service is called the AWE Gathering and has a much smaller attendance which is somewhat stable as of June 2012.

 Building Bridges – The taskforce started with looking at three main objectives to explore in the first three to six months. These include research of what groups are doing in Benicia and Vallejo, involvement of IAF, and events to bring interested groups together.

They plan to develop a new website/blog to post all of our research regarding area services once this is completed. On May 16, 2012, Nora Gauger coordinated a successful gathering of Benicia non-profit groups at CCC-UCC. In



addition, several members attended a two-day community organization training session by the IAF. The taskforce has also met once with Missions and Outreach Committee and others to make plans for the initial steps in discerning the church's interest in building bridges topics and putting the IAF training to work.

• Resurrect the Capital Improvements Plans – The committee has met often and done much analysis and development work, including reviewing original site plans and speaking with construction experts, Benicia City Hall, and financial institutions. They are initially focusing on the major problem of our parking lot: the need for re-paving and potential re-grading. On June 10, 2012, the taskforce presented a major decision to the Congregation at the Annual Congregational Meeting: To fund either of two options for re-constructing the parking lot. The Congregation voted to pursue the option of re-grading the parking lot from four to two tiers while planning utilities and other structures for eventual expansion. This option is the more expensive option, but allows for expansion and growth in pursuit of our future.

#### Futuring as a Sustaining Activity

The Futuring Planning Committee decided on several actions and processes to achieve this including a poster of "The Well" of ideas that might inspire future action, periodic Bridge articles, a bulletin board, a committee for "Sustaining Our Future", and commissioning Jim Lessenger to write a comprehensive final report on the Futuring efforts of 2011-2012.

#### WHAT'S NEXT?

The theme of last year's WITT retreat, this question is one on which we've spent a good deal of time and effort this past year at CCC in an effort to determine how we might minister more effectively to the increasingly wider demographic that our church both reaches out to and represents. A number of answers have been suggested, one of which realizes a dream harbored by Rev. Renie from the day she arrived—that of starting an alternative service that would offer a different style of worship and appeal to a different group of people from those who traditionally attend our, or any, Sunday service. To



date, not one but two such services have emerged, one of them being the SOUL service, "Sing Out Universal Love," an informal, lively, and largely music oriented service. With the help of a planning committee guided by Rev. Renie's vision, this service got off the ground in March under the capable musical leadership of Deborah Shanks and Bruce Smith along with Nancy and Dean Gilman and Leslie and Stuart Blackie. Carla Goad and Barbara Hamm have also participated in musical leadership.

Musically anchoring and supporting the Sunday morning worship service at CCC is the Sanctuary Choir, which sings every Sunday September through June (except for the youth-led service on Pentecost Sunday). This year we sang the most widely varied repertoire of the sixteen years I have been at CCC; we take seriously the Scriptural injunction to "sing a new song"! A special thank you goes to Howard Gill for his wonderful solo with the choir anthem on June 3. (Names of all participants in all groups are listed at the conclusion of my report.)



The Girls' Choir gained some new members and sang several times throughout the year, as did the Women and Girls' Chorus, comprised largely of singers from the Sanctuary and Girls' Choirs.

CCC also offers a rich variety of instrumental music: the Rolling Tones Handbell Choir, the annual Christmas Orchestra, Jazz Gorilla, and the musical group that leads the

SOUL service, as well as occasional instrumental solos and duets. Of the Rolling Tones Handbell Choir, Director Leslie Lessenger writes the following:

The Rolling Tones Handbell Choir continued to gain in experience and skill. They played in church about once a month and also accompanied the choir and the congregation on occasion. In addition, we provided holiday music for the community at Baskin Robbins in December. In February the entire choir attended the Bay Area Handbell Festival in Oakland. Church members and friends had the opportunity to make a donation to the handbell fund and receive a musical valentine at their home on February 14.



The annual Christmas Orchestra accompanied Christmas carol sing-alongs for the worship service on December 11 and for CCC's Home-Made Christmas Concert on December 16.

Jazz Gorilla, comprised of Dean Gilman on bass, Shelby Riddle on clarinet, and Barbara Hamm on keyboard, frequently accompanied Sunday services and also played for a number of community events: a benefit for the Benicia Human Services Fund at the Winterhawk Winery; the San Francisco Scottish Fiddlers concert at CCC; the Blue Christmas Service at St. Paul's Episcopal Church; a Christmas concert at Merrill Gardens; CCC's Home-Made Christmas Concert and Christmas Eve and Christmas Day services. They also played for a Women's Symposium sponsored by the American Association of University Women at Arts Benicia.

Many other musicians also performed in the community and beyond: Cholé McGraw with Vallejo's Melody Chorale; Leslie Blackie with Pleasanton's Broadway Chorus; Gail Mason and Nancy and Dean Gilman with Oakland's Cantare Con Vivo, including a tour to Spain the end of June with performances in Barcelona, Granada, Valencia, and Madrid; Kathleen Kravets in productions with

the Napa Valley Conservatory Theatre, the Royal English Opera Company at the Dickens Faire in San Francisco, and the Walnut Creek Festival Opera; Larry Schaffer with the Brentwood Summerset Singers. Laura Pyles, Kim Webb, Nancy and Dean Gilman, and Barbara Hamm sang with the Vallejo Choral Society, while Shelby Riddle and Dean Gilman played in the San Francisco Scottish Fiddlers spring concert series. Dean also has several projects in tow with his recording company, Alchemist Productions.

Deborah Shanks contributed in varied ways to CCC's music program, playing organ, piano, and guitar, as well as arranging several pieces for both the Sanctuary Choir and the Rolling Tones. In the summer she directs a choir at the Community United

Methodist Church of Port Hadlock, Washington. Deborah, Annette Cook and Gail Mason have accompanied CCC's worship services in the absence of the Music Minister. Chris Francis, aided by spouse Rick Beeson, conducted a drum circle at CCC in November. Among our youth, Katie Stamm-Kirk, Christopher Hanna, and Stuart Blackie played in the annual Christmas Orchestra and in the Pentecost band at CCC for the youth-led service, as well as in their respective school bands and music events.



Music Minister Barbara Hamm led music beyond the doors of CCC at several events. She conducted two workshops in July at the UCC Synod in Tampa, Florida; led music while on vacation in August at the Disciples of Christ Church in Olathe, Kansas; accompanied a Disciples of Christ Women's Retreat at Mission Springs in September; accompanied a Women's Healing Retreat in February at the Disciples of Christ Church in Loomis; accompanied in March a workshop/worship service led by Dr. Marcia McFee at Skyline Community Church in Oakland; accompanied the

opening night service of the NCNC-UCC Conference's Annual Gathering and conducted a sing-along for the Bay Association Meeting at Annual Gathering. Barbara ended her musical church year by leading two workshops at the UCC Musicians' National Network Conference in Kansas City June 22-25 at Country Club Congregational Church. One of her hymns was sung in the Sunday morning worship service with that congregation.



For all of these opportunities to serve at CCC and elsewhere, I am so grateful. And for all the musicians who willingly serve God and God's people with their many talents, I give my heartfelt thanks. What's next? Though we do not know for sure, we will endeavor faithfully to follow where God leads us, praising God with tambourine and trumpet and singing with our whole heart. *Deo Gloria*.

I was blessed to have an active leadership role in Sunday worship service, participating in important church rituals as communion, baptism and even funerals. Pastor Renie graciously gave me the opportunity to preach at least once each month and I had the honor of leading the faith study groups this past year. As CCC-UCC continued in the futuring process this year I also had the opportunity to work with many of you, exploring ways to build bridges into our community in order to make a difference - work that is vital and will be on-going. This past year the Committee on Ministry approved me to move forward with my ordination in the United Church of Christ and I was granted a license for ministry. The license will come in handy as I move into the role of sabbatical supplement here at CCC-UCC while Pastor Renie embarks on a well-deserved three month sabbatical. This is a role I am very excited about and I cannot think of a better place to begin my formal ministry. What a summer it will be.

Out of that arose the SOUL Saturday night musical service, and the more meditative AWE service, both on separate Saturday nights once a month. The Building and Grounds task force also came from the Futuring process, where we saw a need to improve and fix our physical plant and grounds and took the first step at our June Congregational meeting voting to hire an architect and get estimates for a two-tier parking area. This is a long term process but we have set the stage for the expansion of our facilities to handle the needs of our community.



The other major area that I was involved in this year was bringing to our Congregation in our January meeting the Conference salary guidelines (Northern California Nevada Conference using the Bay Area guidelines) and where our Pastor's salary fell in that picture. It was clear by the end of the presentation, that our Pastor was barely above minimum conference guidelines. As a justice issue to our Pastor, who has done all and more as requested in her job description, our Congregation stepped out in faith and voted a significant pay raise to get her above the average for the conference guidelines. The congregation then lived into that faith during our stewardship campaign, significantly increasing pledging to cover this needed additional expense during tough economic times.

While I did not enter my Moderator year with any specific goals in mind, several needs became apparent and I was able to help these come to a resolution. Thank you all for allowing me to serve our church this year as your moderator. It has been my honor and pleasure.

#### **TREASURER**

Dale Olm

It has been an interesting and exciting fiscal year. The congregation made several mid-year "leaps of faith" that resulted both in hiring a pastoral assistant to augment the pastor's work schedule and also brought our pastor's compensation up to "industry standards", each a major advance for this church. As reported to the congregation, we anticipated that these mid-year changes (plus one additional payroll period than anticipated due to the fiscal calendar) might result in a deficit of up to \$10,000. If fact, however, the deficit was kept to \$3,383 largely through the efforts of committee chairs and administrators to curtail expenses, but also through the generosity of our parishioners. Thank you!



Starting in 2006, our budget committee chaired by Carl Mason started setting aside annual funds in anticipation of the sabbatical leave that our pastor would be taking in 2012 (we had not even called our new pastor yet!). Because of that foresight by our financial planners, we are adequately prepared to retain an excellent sabbatical replacement pastor during Pastor Renie's leave this summer.

We use a hybrid cash and accrual accounting method for the church and we divide revenue and disbursements between a working or operating budget and a restricted fund system for contributions donated for designated purposes (i.e., missions, capital improvements, youth group, etc.). This has led to some confusion as to where the church funds come from and go to. The "Cash Flow Report," hopefully helps clarify how all these funds are received and distributed. In the coming 2012-2013 fiscal year, Mission and Outreach has been folded into the operating budget. Ten percent (a tithe) of individual (pledge and "loose offering") donations will be set aside for Mission and Outreach.

It has been a pleasure and an honor to serve the church as treasurer this year.

#### **BUILDING & GROUNDS**

Greg Cox & Jim Lessenger

The main focus this year was futuring. The major outcome relating to building and grounds

stewardship was the formulation of the Capital Improvement Taskforce to look at the parking lot repair/replacement. The task force led by Jim Lessenger and Marlan Shanks included several members (Leslie Lessenger, Dale Olm, Mike Hill, and Greg Cox). Jim and Marlan met with city Planners and a local general contractor, R3 Builders, to review the option of repairing the parking area as is or to redesign the parking area to accommodate future growth including a new fellowship hall or sanctuary.

The plan was put to vote and approved at the congregational meeting June 10, 2012. At this time we will be hiring an architect to develop

detailed plans for building a new two-tier parking area, including landscaping and plans for access to the gazebo area.

Two wide screen monitors were installed in the sanctuary. Many thanks go to Mike Hill who designed and supervised the installations. These are a great addition to our worship and now we



can view the words of the hymns without having to look down at the hymnals.

The major area of concern this year was the upkeep of the grounds. We looked into hiring a landscape contractor, but at a cost of \$800 a month this is currently not in the budget. An adopt-a-weed program was developed to allow members to select an area of the ground to keep weeded and clean. This is going slowly, but already 50% of the property has been adopted by members. We encourage participation by

everyone in this effort to keep the grounds in the best condition possible.

We continue to employee Maids Above the Rest as our janitorial service. Jacque has kept the place in excellent shape and on a couple occasions has cleaned twice in the week at no extra charge when we had special events.

#### **Building Use**

Our facility continues to serve the community in whole by providing a safe space where everyone is welcome no matter who you are. As part of our social outreach to the community we continue to support the following groups by extending the use of our facilities.

- Happy Hearts Jackie is now the sole owner and now into the eighth year offering yearround classes. We have ongoing communication and yearly review of agreements.
- AA\NA\ALANON We now host the only Women's AA group in the area on Wednesdays.
   Weekly meetings are posted on the church calendar at (<a href="http://www.cccucc.org/">http://www.cccucc.org/</a>) or in the monthly Bridge.

Building and Grounds fellowship day will continue to be held on the fourth Saturday of each month through October 2012. They will resume again in January 2013. Please mark your calendars with these important fellowship events before your schedule gets busy. It takes everyone's help no matter what they can contribute to continue our growth. Donations are always welcome and can really help to hire labor, rent equipment, or purchase plants, trees, benches, etc. Please contact

me if you can assist in this way. Our fellowship team Allison and Karen make the work days a pleasure to attend. I know our friends from Genesis House in Vallejo look forward to these home cooked meals at our work days. My vision for Fellowship over the last four years has been based on two guiding principles:

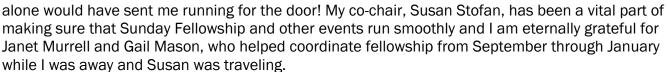

#### MISSION & OUTREACH

This has been a year of transition for Mission and Outreach. On one hand, we have been busy addressing our usual tasks, but we have also been working with Pastor Renie, the Futuring Committee, and the Stewardship Committee, all under the auspices of the Council, to better integrate mission into the whole life of the church.

As part of our effort to increase congregational participation in mission, the emphasis this year was on tangible giving — bikes for migrants in Pescadero, a food drive during February, socks and gloves, etc. for SF Night Ministry, Christmas gifts for Benicia families in need through CAC, starter packets for aged-out foster children at Easter, etc. With everyone's mission pledge this year being incorporated into the general fund, Mission and Outreach will be concentrating much more on bringing local mission opportunities to the congregation and working with others to make that mission count.

This year, M&O took the following actions:

 Each month, we presented information and the opportunity to donate to the following missions selected by the M&O committee:

July: Fisher House January: Heifer International (Youth Project)

August: Night Ministry of San Francisco February: Solano County Food Bank

September: First Place for Youth March: Solano Land Trust

October: Neighbors in Need (UCC)

April: One Great Hour of Sharing (UCC)

November/December: CAC Adopted Families May: SF Night Ministry

Christmas Eve: The Christmas Fund (UCC) June: Strengthen the Church (UCC)

Note that we changed our May Mission from Rebuilding Together to SF Night Ministry to coordinate with Howard Gill and the Youth, since May turned out to be a better time for the youth to make their visit.

Each mission chosen was selected only after being carefully researched and deemed to best represent our church's interests and Jesus' mandate. An amount of \$400 from the Mission Pool was added to the money donated by the congregation to each mission during the month it was featured.

- In August of 2011, we took on a special project. With the help of the Youth and our Change for Change jar, we supplied not only the usual backpacks to Puente de la Costa Sur, a migrant ministry in Pescadero that we work with, but also collected and transported 16 used bicycles for migrants on isolated ranches to give them some independence. Ron Smith
  - drove the rented truck, the youth and a number of volunteers went along to deliver the bikes and backpacks and share a meal with the Puente teens. The whole congregation participated in donating the money needed to fill the backpacks, fix the bikes and rent the truck.
- At Christmas, the congregation joined us in purchasing gifts for Benicia families in need (as identified by CAC) and, by donating to our "Instead of Poinsettias altar decoration," supplied basic clothing and

food to those same families. At Easter, we used a similar theme—"Instead of Lilies altar decorations" to provide independent-living starter kits (and two new baby starter kits) for aged-out foster teens (as identified by First Place for Youth).

- In January, 2012, the M&O committee authorized a one-time donation of \$1,000 from the
  Mission Pool to the Benicia non-profit, Families in Transition, which helps Benicia families
  with back rent. This donation replaced the amount slated to be collected during Worship in
  Park as that event was cancelled last fall.
- Starting this last January, the M&O committee has sponsored a Social Justice table during the Fellowship Hour at least one Sunday each month. This table displays information from

both the current Mission of the month and other timely issues currently in the news. With the upcoming election season on us, the M&O committee intends a special effort to make accurate and objective information on the Propositions on the November ballot available for the congregation through the Social Justice table.

This year's Mission and Outreach committee is to be commended for their willingness to consider, discuss, and make thoughtful decisions governing how we as a church fulfill the commitment we have expressed in our Mission statement—that we follow the example set by Jesus. Working with these dedicated members of our church has been extremely rewarding for me—and I thank every one of them. I encourage anyone with an interest in how we "do mission" in this church to join our group as we move forward to the new challenges and opportunities brought by our new fiscal year.

The Stewardship Committee had a busy year both in fund raising for our operating budget and in our Stewardship campaign.

We had a very successful fall auction, bringing in \$4,520. We also had our March Crab Feed fund raiser which was fun and well attended and raised \$1,331. We had a 50/50 raffle at the Crab Feed that brought in an additional \$392.

Our Stewardship Campaign's theme was *Live, Love and Lead.* We chose to mail an appeal with a pledge card rather than use the pass-around notebook method this year. The campaign had testimonials and we urged every member to pledge something.

Dale Olm gave a final appeal for pledges after the campaign ended. This moving plea, given from the lectern, stated that we would be presenting a balanced budget to be voted on in June by the congregation. The question we had to answer as a congregation was what that budget would look like and if we would be reducing and/or cutting needed and desired programs, staff and ministries to balance it. Dale left us with the challenging question of "what do



we want to be as a church", and emphasized that we were voting what we wanted to be through our pledging.

This appeal resonated with our members and the pledges increased significantly over the next few weeks as our congregation pledged an additional \$22,000 to make our total pledges for the upcoming year \$142,798. Our congregation voted to have a church that supports our youth, outreach and missions, music, a full time pastor, support staff and more. We voted to keep our church moving forward at a time when it is so desperately needed.

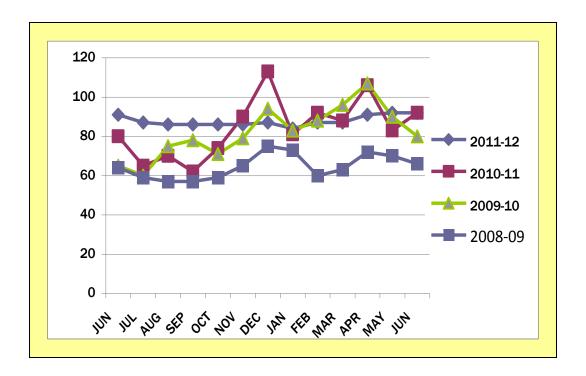

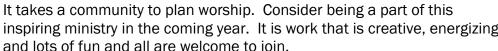

Documents from the Futuring program are now archived in a file along with those with the re-Visioning program of 2004. I provide a lecture to the confirmation class every year on the history of the religion and the church. We continue to have the history box every week and encourage the children of the church to select and prepare a theme.

There is only so much room in the archives closet. So, beginning next year we are going to review the files, discard any duplicate materials, and consolidate. We plan to maintain the outline and perhaps integrate photographs of various individuals.

We are still missing files from entire years, so check your cabinets.

Remember that the 150<sup>th</sup> anniversary of the church will be in four years. I have started collecting representative photographs, histories and documents to integrate into a book. It should be fun.

If anyone has any further documents or artifacts, please bring them to me at any Sunday service. When submitting photographs, be sure to write in pencil on the back the names of the persons in the photo and the year the photo was taken.

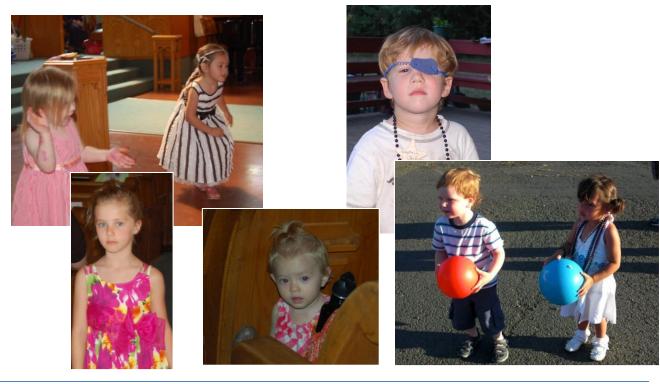
> had visitors from other states. We meet Tuesday mornings at 10AM. And you don't have to drink coffee.
